- focusing efforts on improvements that most impact outcomes, meet cost containment goals, and increase revenues

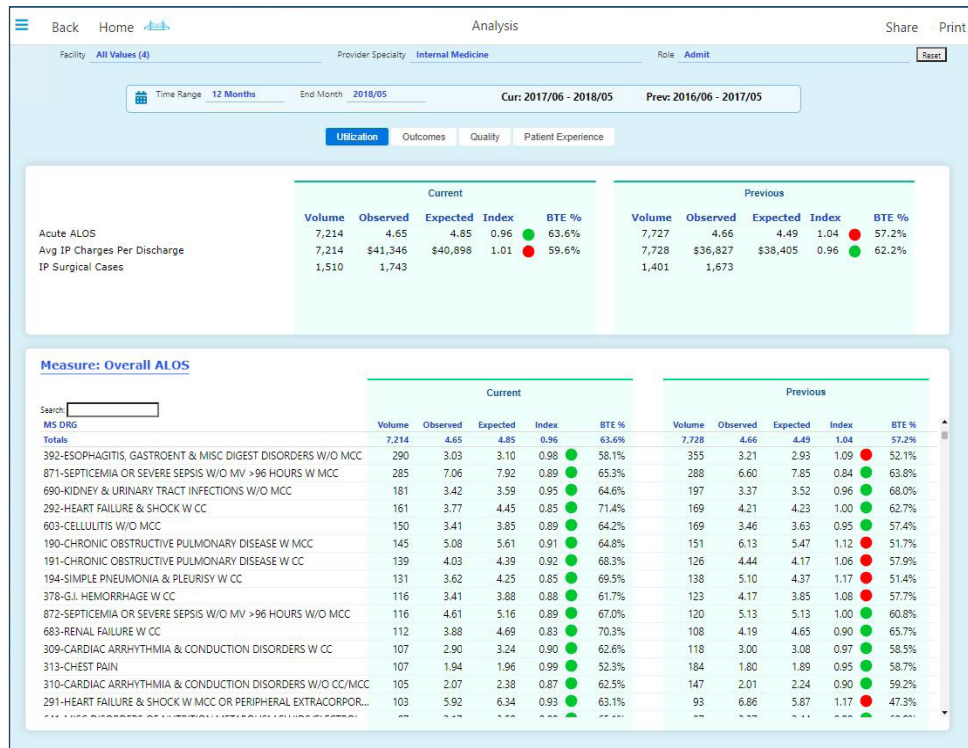
## Streamline Access to Data through Powerful Data Integration
